## 24HR URINE COLLECTION INSTRUCTIONS

WARNING: This bottle contains strong acid (6N HCI). DO NOT DISCARD. Do not urinate directly into container.

## **Materials supplied:**

24 hour urine container 25 mL of Hydrochloric Acid (6N HCL) inside the container

## Materials needed but not supplied:

Requisition completed by physician or clinic

#### **Collection Guidelines:**

- Collect urine output for a full 24 hour period.
- Restrict caffeine, nicotine and alcohol 24h prior to collection.
- Discontinue methyldopa (Aldomet) at least 5 days prior to collection.
- Avoid reserpine, alpha methyldopa, levodopa, monoamine oxidase inhibitors.

### Do not stop taking any medication unless advised to do so by your doctor.

Some medications may interfere with the results of this test and are known to give false evaluations. If medications cannot be discontinued, please provide a list of medications to the laboratory. It may be possible to eliminate interference by special procedures.

## **Example:**

Start Time→ 7:00 AM January 01, 2019 → Empty bladder (DO NOT Collect Urine)

• For the next 24 hours, collect urine output using a sterile container and transfer into the 24 Hr. container provided by the laboratory. Please gently mix/invert the bottle with each addition.

Finish Time→ 7:00 AM January 2, 2019→ Collect urine sample (Last Collection)

#### **Delivery to the Lab:**

- Sample must be labelled with your Name, Date Of Birth, MRN # and /or OHIP
- Ensure the START/FINISH dates and times are written on the requisition
- Make sure the lid is tightly fastened
- Deliver specimen to: Blood Collection Site or Core Lab. 2<sup>nd</sup> Fl Cardinal Carter Wing **as soon as possible.**

**Note:** The sample container contains toxic substance of hydrochloric acid additive. Avoid Eye Contact, Skin Contact, Ingestion, and Inhalation of contends in the container.
